

The Council of the London Borough of Hillingdon (hereinafter referred to as “the Council”) in exercise of its powers under Sections 45, 46, 51 and 124 of and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984¹ as amended by The Local Government Act 1985², The Road Traffic Regulation (Parking) Act 1986³, the Parking Act 1989⁴ and The Road Traffic Act 1991⁵ and all other powers enabling it in that behalf and after consultation with the Chief Officer of Police hereby makes the following Order.

1. This Order shall come into operation on the XXX 2024 and may be cited as The Hillingdon (On Street Parking Places) (Hillingdon Hill Parking Management Scheme) Zone HN1 Order 2023 (Amendment No. X) Order 2024.

Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order as The Hillingdon (On Street Parking Places) (Hillingdon Hill Parking Management Scheme) Zone HN1 Order 2023⁶ shall have effect as though the parking place numbered 16 in Schedule 1 of that Order was deleted.
