Hillingdon Council gives notice that it proposes to make this Order to **introduce a one way working within Crescent Parade, Uxbridge Road, Hillingdon** so that vehicles may only travel in a southerly and then westerly direction when entering Crescent Parade from Long Lane. No entry into Crescent Parade from the junction with Uxbridge Road. 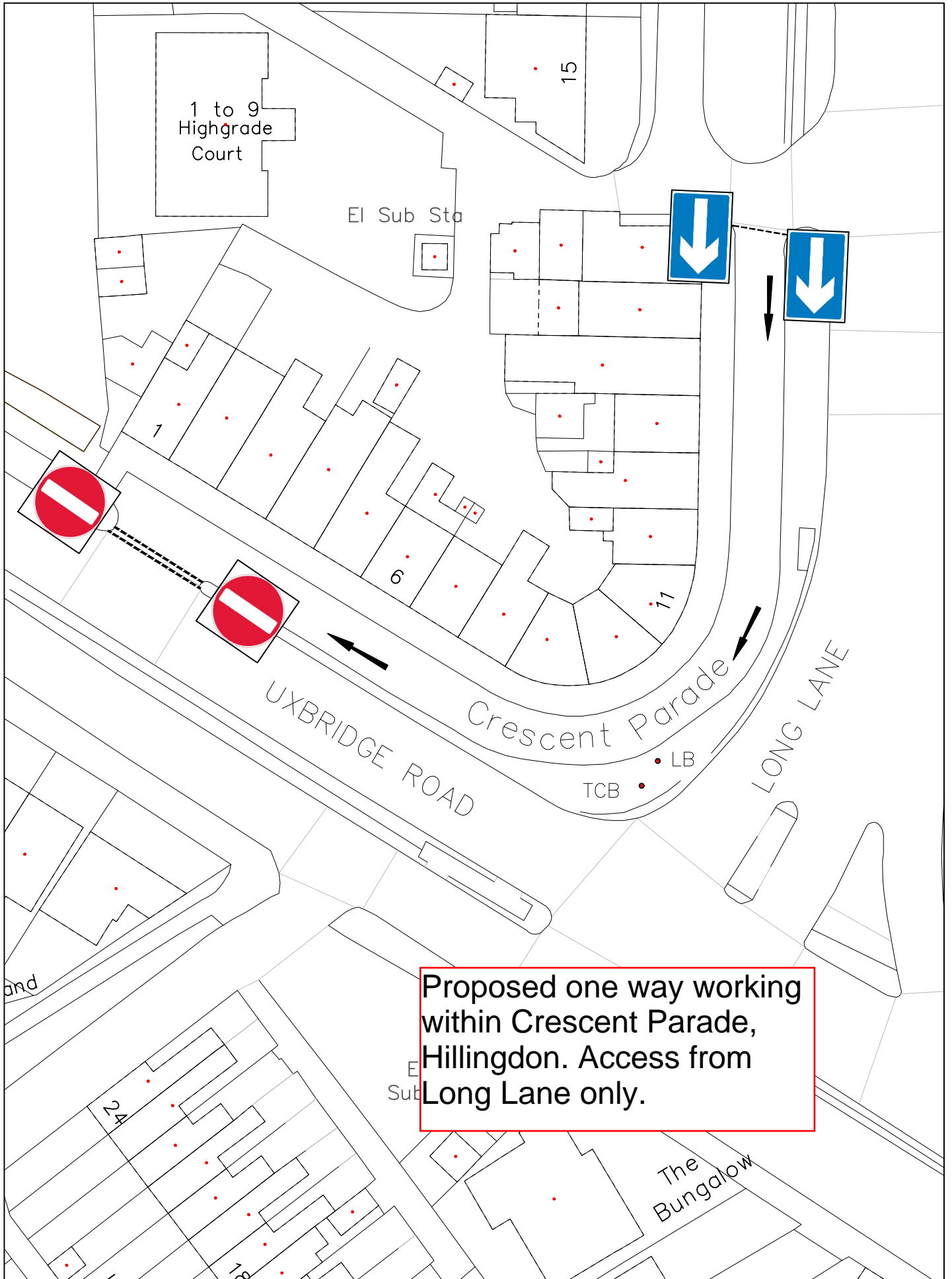

The London Borough of Hillingdon after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Section 6 of the Road Traffic Regulation Act 1984¹ as amended by Section 8 and Schedule 5 of the Local Government Act 1985² and all other powers thereunto enabling, hereby make the following Order:-

1. This Order shall come into operation on the XX and may be cited as The Hillingdon (Prescribed Routes) (No. X) Traffic Order 2026.
2. No person shall cause any vehicle to proceed in either an easterly or northerly direction within the service road known as Crescent Parade, Uxbridge Road, Hillingdon.
3. No person shall cause any vehicle to enter the service road known as Crescent Parade, Uxbridge Road, Hillingdon from its junction with Uxbridge Road.
4. Nothing in Articles 2, 3 or 4 of this Order shall apply to:-
 - (a) any vehicle being used for ambulance, fire brigade, or police purposes; or
or
 - (b) anything done with the permission or at the direction of a police constable in uniform; or
 - (c) any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to Section 66 or Section 57 of the Road Traffic Regulation Act 1984.
